

Market overview

Markets reacted unfavorably during the first quarter of 2025 after a string of weakening soft economic releases, including declines in consumer sentiment and business surveys. Meanwhile, 1-year inflation swaps climbed 72 basis points to 3.25%. The Federal Reserve held policy rates steady throughout the quarter amid elevated uncertainty. However, fed-funds futures shifted to price in three 25-basis-point rate cuts in 2025, up from two at the start of the year. Over the quarter, the 10-year yield decreased by 36 bps. The Bloomberg U.S. Aggregate Bond Index posted gains of 2.8% while the Bloomberg U.S. Corporate Bond Index underperformed by 0.5%, returning 2.3% during the period. Credit spreads in high-yield corporate bonds widened by 60 bps. The U.S. high-yield bond market underperformed higher-quality bonds by 1.3%, returning 1% as measured by the Bloomberg U.S. Corporate High Yield Bond Index.

Performance

HYHG fell 0.7% during the first quarter based on NAV, underperforming the U.S. high-yield bond market by 1.7%. Credit spread widening negatively impacted HYHG's performance during the quarter, and the embedded interest rate hedge helped shield the strategy from changes in rates.



Performance contribution

The strategy consists of a portfolio of diversified high-yield bonds, combined with short positions in Treasury futures that are designed to offset the interest rate risk inherent in high-yield bonds. The strategy's performance can be broken into these components: 1) high-yield bond yields, 2) the cost of the Treasury hedge, 3) the impact of credit spread changes, and 4) the impact of interest rate changes.

During the quarter, HYHG's bond portfolio yielded approximately 1.7%, while the Treasury hedge did not change. The strategy had losses of approximately 2.5% from credit widening. Because of the interest rate hedge constructed within the portfolio, the strategy experienced approximately zero impact from interest rate movements during the quarter.

With respect to these Nontraditional Bond funds, HYHG received a Morningstar Rating of 5 stars for the three-year period, 5 stars for the five-year period, and 5 stars for the ten-year period.
