

## How Did the Fund Perform Last Year?

MSCI Transformational Changes ETF (the "Fund") seeks investment results, before fees and expenses, that track the performance of the MSCI Global Transformational Changes Index (the "Index"). The Fund invests in financial instruments that the Advisor believes, in combination, should track the performance of the Index. Tech and techrelated outperformance overcame sizable healthcare exposure to deliver modest outperformance compared to the Nasdag-100. For the year ended May 31, 2025, the Fund had a total return of 17.59%. For the same period, the Index had a total return of 17.88% and a volatility of 16.71%. Primary factors affecting Fund performance include the total return of the securities held by the Fund, expenses, transaction costs, the volatility of the Fund's index, and other miscellaneous factors.
