

How Did the Fund Perform Last Year?

Bitcoin & Ether Market Cap Weight ETF (the "Fund") seeks investment results, before fees and expenses, that correspond to the performance of a market-capitalization weighted basket of bitcoin and ether. The Fund invests in financial instruments that the Advisor believes, in combination, should produce daily returns consistent with the Fund's investment objective. Bitcoin's returns were driven in part by geopolitical uncertainty and rising government debt, boosting the appeal of this "digital gold" with no tie to nation-states. Ether returns experienced weakness during the period in part due to developing competition from alternative coins. For the year ended May 31, 2025, the Fund had a total return of 23.90%. Primary factors affecting Fund performance include the total return of the derivatives held by the Fund, including the performance of the reference assets to which any derivatives are linked, expenses, transaction costs, and other miscellaneous factors.

Effective on or about September 27, 2024, the Fund's name changed from ProShares Bitcoin & Ether Market Cap Weight Strategy ETF to ProShares Bitcoin & Ether Market Cap Weight ETF, and has as a Principal Investment Strategy that the Fund will invest, under normal circumstances, at least 80% of its total assets in instruments that provide exposure to bitcoin or ether or in instruments with similar economic characteristics.
