
How Did the Fund Perform Last Year?

Ultra Bitcoin ETF (the "Fund") seeks daily investment results, before fees and expenses, that correspond to two times (2x) the daily performance of the Bloomberg Bitcoin Index (the "Index"). The Fund invests in financial instruments that the Advisor believes, in combination, should produce daily returns consistent with the Fund's investment objective. Bitcoin's returns were driven in part by geopolitical uncertainty and rising government debt, boosting the appeal of this "digital gold" with no tie to nation-states. For the year ended May 31, 2025, the Fund had a total return of 50.86%. For the same period, the Index had a total return of 54.64% and a volatility of 51.95%. Primary factors affecting Fund performance include the total return of the derivatives held by the Fund, including the performance of the reference assets to which any derivatives are linked, financing rates paid or earned, the types of derivative contracts used (and their correlation to the Fund's Index), expenses, transaction costs, the volatility of a Fund's Index (and its impact on compounding), and other miscellaneous factors.
