

How Did the Fund Perform Last Year?

Ether ETF (the "Fund") seeks investment results, before fees and expenses, that correspond to the performance of ether. The Fund primarily invests in ether futures contracts, which the Advisor believes should produce returns consistent with the Fund's investment objective. Ether returns experienced weakness in part due to developing competition from alternative coins. For the year ended May 31, 2025, the Fund had a total return of -36.74%. Primary factors affecting Fund performance include the total return of the derivatives held by the Fund, including the performance of the reference assets to which any derivatives are linked, expenses, transaction costs, and other miscellaneous factors.
