

How Did the Fund Perform Last Year?

Equities for Rising Rates ETF (the "Fund") seeks investment results, before fees and expenses, that track the performance of the Nasdag U.S. Large Cap Equities for Rising Rates Index (the "Index"). The Fund invests in financial instruments that the Advisor believes, in combination, should track the performance of the Index. Roundtrip of interest rates and underperformance of the energy sector contributed to muted returns. For the year ended May 31, 2025, the Fund had a total return of -1.30%. For the same period, the Index had a total return of -0.98% and a volatility of 18.64%. Primary factors affecting Fund performance include the total return of the securities held by the Fund, expenses, transaction costs, the volatility of the Fund's index, and other miscellaneous factors.
