The Fund invests in financial instruments that the Advisor believes, in combination, should track the performance of the Index. ROBLOX outperformance contributed to outperformance relative to the Nasdaq-100. For the year ended May 31, 2025, the Fund had a total return of 37.43%. For the same period, the Index had a total return of 40.31% and a volatility of 20.14%. Primary factors affecting Fund performance include the total return of the securities held by the Fund, expenses, transaction costs, the volatility of the Fund's Index, and other miscellaneous factors.
