

# How Did the Fund Perform Last Year?

S&P 500 Ex-Energy ETF (the "Fund") seeks investment results, before fees and expenses, that track the performance of the S&P 500 Ex-Energy Index (the "Index"). The Fund invests in financial instruments that the Advisor believes, in combination, should track the performance of the index. Performance was driven by strong performance of the S&P 500 and roughly in-line performance of the energy sector. For the year ended May 31, 2025, the Fund had a total return of 14.31%. For the same period, the Index had a total return of 14.45% and a volatility of 19.90%. Primary factors affecting Fund performance include the total return of the securities held by the Fund, expenses, transaction costs, the volatility of the Fund's index, and other miscellaneous factors.
