

## How Did the Fund Perform Last Year?

S&P 500 Ex-Financials ETF (the "Fund") seeks investment results, before fees and expenses, that track the performance of the S&P 500 Ex-Financials and Real Estate Index (the "Index"). The Fund invests in financial instruments that the Advisor believes, in combination, should track the performance of the Index. Strong performance of the financial sector drove underperformance relative to the S&P 500. For the year ended May 31, 2025, the Fund had a total return of 11.65%. For the same period, the Index had a total return of 11.85% and a volatility of 20.57%. Primary factors affecting Fund performance include the total return of the securities held by the Fund, expenses, transaction costs, the volatility of the Fund's index, and other miscellaneous factors.
