How Did the Fund Perform Last Year?

Smart Materials ETF (the "Fund") seeks investment results, before fees and expenses, that track the performance of the Solactive Smart Materials Index (the "Index"). The Fund invests in financial instruments that the Advisor believes, in combination, should track the performance of the Index. Underperformance of OLED and the S&P 500 materials sector hampered performance. For the year ended May 31, 2025, the Fund had a total return of -13.12%. For the same period, the Index had a total return of -13.28% and a volatility of 19.48%. Primary factors affecting Fund performance include the total return of the securities held by the Fund, expenses, transaction costs, the volatility of the Fund's index, and other miscellaneous factors.
