How Did the Fund Perform Last Year?

Nanotechnology ETF (the "Fund") seeks investment results, before fees and expenses, that track the performance of the Solactive Nanotechnology Index (the "Index"). The Fund invests in financial instruments that the Advisor believes, in combination, should track the performance of the Index. Healthcare exposure drove weak performance. For the year ended May 31, 2025, the Fund had a total return of -20.92%. For the same period, the Index had a total return of -20.63% and a volatility of 32.25%. Primary factors affecting Fund performance include the total return of the securities held by the Fund, expenses, transaction costs, the volatility of the Fund's index, and other miscellaneous factors.
