

How Did the Fund Perform Last Year?

Russell U.S. Dividend Growers ETF (the "Fund") seeks investment results, before fees and expenses, that track the performance of the Russell 3000[®] Dividend Elite Index (the "Index"). The Fund invests in financial instruments that the Advisor believes, in combination, should track the performance of the Index. An underweight to the technology sector drove underperformance relative to the Russell 3000. For the year ended May 31, 2025, the Fund had a total return of 4.03%. For the same period, the Index had a total return of 4.39% and a volatility of 15.31%. Primary factors affecting Fund performance include the total return of the securities held by the Fund, expenses, transaction costs, the volatility of the Fund's index, and other miscellaneous factors.
