# How Did the Fund Perform Last Year?

Metaverse ETF (the "Fund") seeks investment results, before fees and expenses, that track the performance of the Solactive Metaverse Theme Index (the "Index"). The Fund invests in financial instruments that the Advisor believes, in combination, should track the performance of the Index. Several "Magnificent Seven" and stocks related to artificial intelligence drove performance modestly outperforming the Nasdaq-100. For the year ended May 31, 2025, the Fund had a total return of 18.47%. For the same period, the Index had a total return of 18.25% and a volatility of 31.90%. Primary factors affecting Fund performance include the total return of the securities held by the Fund, expenses, transaction costs, the volatility of the Fund's index, and other miscellaneous factors.
